Lasting Memories from the 2016 North Central Jurisdiction Meeting "A Fresh Wind Blowing"



God Prepares Us


*To set the context for this article . . .
At a Detroit Conference School of Christian Mission held at Adrian College sometime in the latter 1980's, a small group of us were chatting, and the topic came up about there being "an African American national anthem" ...that being out of the experience of those us from a more rural culture of Michigan.*

A busload of United Methodist Women traveled to Cleveland in the spring of 1992, I believe. Arriving at our hotel in mid-afternoon, we found our rooms, unpacked & freshened up for dinner in a large elegant ballroom, holding 300 or so attendees, seated at large banquet round tables. At each setting was a green United Methodist Hymnal w/the logo of this gathering embossed in gold on its cover. This denominational edition of the hymnal had been recently published at this time.

As dessert tableware was being cleared, a welcome and introductions began, followed by Mattie Henderson singing "His Eye is on the Sparrow". And then, it seemed to me, very spontaneously, the keyboard musician transitioned into another piece, and all of a sudden it seemed that the entire room was standing and singing! But then I noticed it was the Black women who were standing & singing, and so we of the dominant culture stood and joined them, sensing something extraordinary was happening, taking our hymnals and looking for what they were singing, so we could join with them in this very special moment!

For me, this moment was full circle from that casual conversation 8 or 10 years prior, God preparing me to know the answer to that musing we pondered. I'm getting goosebumps just sharing this experience with you . . . oh, the ways God prepares us to not only be a community of women, but a citizen of the world!


