After returning to Ohio, she started attending United Methodist Women events at Central Trinity and became a member there. She was soon asked to join the Foothills District leadership team as communications coordinator and worked to update the District Standing Rules before she became district president. For the West Ohio Conference, she served as secretary and the chair of the Conference Standing Rules Committee. At present, she is a member of the Foothills District Committee on Nominations and president of Central Trinity United Methodist Women. 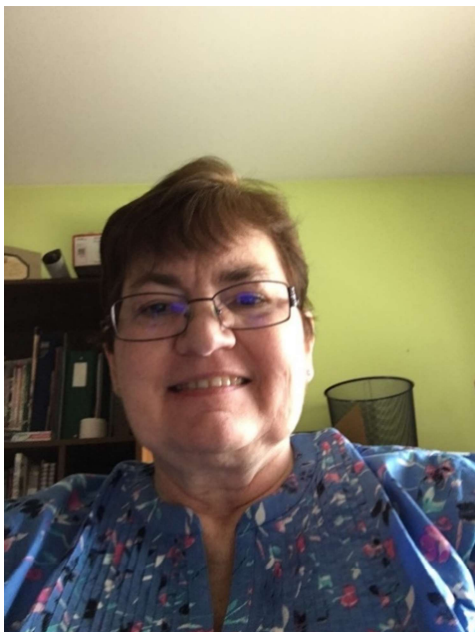

In March 2020, Marilyn completed twelve years of voluntary service as a director and vice president of UMCMG, Inc., a community-based nonprofit organized for charitable, religious, and educational purposes. She is a member and secretary of the Northern Illinois Conference Commission on Archives and History and a volunteer researcher in the stored archives.
